b. Proposition 101 Estes Park neighborhood ADA ramp, beautification, and paving project: Prop 101, related to

Estes Park. Money was set aside for beautification and to make ramps ADA accessible. And repaving the road. They won't get to that until November. Project Manager, Dustin from the city, he will be meetinig with Ms. Osollo on October 23 to give an update. Communications person from City of Tucson reached out to Ms. Osollo to give her an update as well. Also going to look at ramps at our school to make sure ours are ADA compliant as well.

c. 2024-2025 proposed 6th grade expansion at K-5 schools: Very tentative. Revisiting the idea of adding 6th grades to schools that feed into Gridley. Met about a month ago and they explained/ asked what pros/ cons were. Today, Ms. Osollo had 2nd meeting with project manager. Talked about space- not wanting ugly portables and also staffing and resources. They're just collecting information. Taking a draft to the board in November. It would be a very small pocket. Parents would have the option to send them to 6th grade AT Gridley OR keep them at the elementary schools. If it doesn't happen this year, then they will get it ready for the following year. It's ALL VERY TENTATIVE and ALL PENDING Board Approval. There are some sites whose communities are already behind it, moreso than ours.
